Application Information/Acceptance

- All food vendors are required to submit a completed application, payment, a Business License issued by the City
 of South Lake Tahoe, El Dorado County Health Permit and a valid California sellers permit. Applications
 submitted without these items will be considered incomplete and will be returned.
- It is the responsibility of the vendor to understand and abide by all facility requirements of the City of South Lake Tahoe and El Dorado Country.
- To be guaranteed entry into the event series, please submit your application by June 1, 2017 at 5:00 PM.
 Applications received after that date are considered LATE ENTRY and will only be accepted if space is
 available, applications are complete, and if time allows.

General Event Information

- Tahoe Truck Stop is a "rain or shine" event, and as such, will not be canceled, nor refunds issued, due to slightly
 inclement weather. However, the event series holds the rights to cancel or postpone an event if weather causes
 a threat to staff/guest safety (i.e. thunder and lightening).
- On Course Events and our team will not be responsible for any theft or damage to your display, merchandise or equipment. It is the responsibility of the vendor to watch over and/or to remove valuable items each evening to secure your tent.
- Behavior that is disruptive, disrespectful, aggressive or threatening in nature WILL NOT BE TOLERATED. Any vendor found to demonstrate such behavior will be ejected from the Live at Lakeview event immediately, without question and without refund, and with law enforcement assistance, if necessary.

Payment Information

- Payment is due with application; at least 15 business days prior to event, unless indicated otherwise in writing.
- Acceptable forms of vendor payment include cash and/or checks.
- · Checks must be made payable to "On Course Events."
- Returned checks will be assessed a \$25 fee.

Refunds

- Refunds will be issued on the following basis. If you choose to withdraw/cancel your participation from the event series once you have been accepted:
 - Withdrawal/cancellation at least 3 weeks prior to scheduled event warrants 100% refund of booth fees;
 - o Withdrawal/cancellation at least 48 hours prior to scheduled event warrants 50% refund of booth fees;
 - We regret that cancellations with less than 48 hours notice will not be refunded.
 - o If you do not show up to the event, there will NOT be a refund.
 - All requests for refunds MUST be made in writing via e-mail to Leslie@oncourseevents.com. If you do
 not receive a WRITTEN reply, assume we have not received your cancellation.

Waiver Information
